Parties:

Jon Estridge: (Senate Intelligence Committee)

Sean Weaver: (Contractor)

5:55am PST

Jon:

Good morning

(link: invitation to download Signal App)

Sean:

Signal is not secure. But we can establish comms there. I will turn it on when I am back in cell range.

Sean:

Good morning- I am back in cell range. Do you mind if we text?

If you prefer signal I can go pick up a secure phone today and put signal on it.

Text is more secure for me than signal - believe it or not.

Jon:

Interesting. Have been told signal is best but you may have additional insights. I can text.

Have received ample positive feedback about you!

We are at a crossroads position whereby members want to partner w industry and find the win/win way forward.

By members I mean numerous Senators that know what is going on.

Sean:

Well, hopefully I can live up to my early reputation. Bear with me as it will take me time to text you. My responses will come across in chunks. Gaps of time. But know I am here for the next 30 minutes texting you.

Jon:

They understand there have been many very good and some bad things have occurred over decades without oversight. They want to "reset and modernize" the situation to the extent possible without risking or undermining any of the important capabilities we may need in a conflict.

Sean:

The contribution I would like to make is primarily via guidance on how to move forward without throwing the baby out with the bath water. Corruption is chronic and ramped, we (the American people) have lost control of the private and federal organizations we spawned nearly 80 years ago. It will take a nuanced comprehensive approach to recover. We didn't get here overnight, and I don't believe we will recover overnight.

First let me be clear about what side I am on. I am on the side of my family first, the American people second, and the U.S. military/government third and only as long as they are taking care of the first two.

For us that work/live in this world, our teams no longer can be identified by the 3-letter agency designators they carry. Teams (individuals with common objectives/orientation) are nebulous networks that propagate across agency boundaries. To keep it simple, let's call it two teams, Team Blue and Team Black.

I define Blue as what should be a unified and discernible organization - codified by elected officials, edified by the spirit of the citizens it serves, and fortified by the uniformed patriots of its armed services.

Team Black was born in 1947 when the President signed the National Security Act which immediately established the formation of new private corporations as well as new agencies including the Department of Defense which included the C.I.A. and The United States Air Force.

At its heart, Team Black was to be covert, bearing the responsibility of the nation's deepest secrets, while the greater Team Blue would stay busy as the nation's overt people's war machine. But, compartmentalization replaced amalgamation and by the 1960's, Team Black, however recognizable on the surface, had evolved an indiscernible leadership structure and a nebulous underbelly. By the end of the 1960's the specialized activities and capabilities of Black Team had gone from covert to completely unacknowledged. Congress, and the office of the president had lost control of the organizations they had spawned 20 years ago. The tail began to wag the dog.

Know that I bleed Blue but was misled a long time ago to believe that was who I served.

Here is what I want to communicate –

There are good people stuck on Team Black. There are also priceless assets. Both of these must be preserved and that starts with preserving the people stuck over here by giving them a path out.

What we all just watched Graves, Grusch, and Fravor do is not a path we can take. Here is why and an alternative I would like to suggest...

While the Whistle Blower Protection Act of 2023 is encouraging to see, it, with all due respect, shows the level of ignorance and arrogance plaguing Congress when it comes to this world. Congress can't protect us.

By no fault of their own, Congress is naive. They think testifying under oath is about TRUTH. It is not, it is about EVIDENCE. And the evidence that would come out of the woodwork to support that what I and others are testifying is all lie, would overwhelm the evidence to the contrary, the contrary being the truth. We the WB (whistleblowers) would be taken out by the same team we are trying to help (Blue) via the repercussions of lying under oath.

Further, 99% of us don't want to become public figures/internet sensations. My rough draft alternative solution...

Jon:

I am heading to a lunch meeting for an hour and look forward to your responses. The bottom line ask is to establish a back channel so that Senators can communicate on some level w industry (completely off record)

Sean:

Copy. Well, I am going to continue text you here while I have the opportunity this morning. After you read everything I send, let me know where we're at and we can continue conversations.

Jon:

I am processing all this and fully understand what you are explaining.

Its not fully clear how I can help and given what you've said Im convinced it's a waste of time to try and establish a back channel

Why would you have to lie under oath?

Sean:

I wouldn't lie under oath.

Which is why I can help by offering suggestions on how to proceed with encouraging others to come forward and where to look

Jon:

Ok just trying to understand. You wouln't lie under oath because you would not come forward?

Do you have thoughts about how congress can enable a win/win scenario?

Sean:

My idea of a practical path out is something analogous to "Conscientious Objector". Not everyone over here, most, don't have the super sexy/juicy stories to tell about ET beings and craft. In fact, the flying machines are not the bulk of the booty to be had. Flying is boring. There is plenty of other technology with applications far more utilitarian than airborne transportation.

If we could create a mass exodus of the "ordinary' people doing the grunt work for Black Team, we could gut the infrastructure. For every high-level leader, scientist, security members, there are 20 more administrators, toilet cleaners and general maintenance personal. We need to go after the mid-level people and get them out first.

These people need a quiet path forward, and they need guaranteed unemployment compensation. It is really that simple I believe, these people need a paycheck until they can get suitable alternative employment.

This brings me to the next subject. For some serendipitous reason the human trafficking subject has become tip of the spear in tandem timing with the UAP subject.

The subject of human traffic is complicated.

Many UAP skeptics ask this question, which is the right question - why don't we hear from more WB's? There has to be hundreds, if not thousands, of people working in these programs/facilities. Who is cleaning toilets and taking out the trash?

This is the right question to ask. Much of the time it is nameless, desperate, and dispossessed and therefore ultimately disposable Third World people. But this gets messy quickly, because if a federal task force was to go kicking in doors you might find yourself liberating people that don't want to be liberated.

While these people are essentially considered biological/pink assets (or equipment), they are treated well - their essential needs are taken care of. Even if they knew what they were getting themselves into, they would still choose to get involved. Because compared to where they come from, these programs offered a major upgrade in their quality of life and hope for the future. So, we have a semantics problem – human trafficking has come to mean sex slavery and drinking the blood of babies. This is not what this is. This is arguably no different than American corporations moving their factories to Mexico and getting cheap labor. Morally I would say it is more line with buying goods from China knowing the circumstances under which people are made to work.

As long as there is a disparaging global economic gap, you will find people being "trafficked" under their own free will.

There are also desperate and dispossessed and therefore ultimately disposable humans prospected within our own borders, within the BIA.

Jon liked message

Jon:

Makes sense. Does the country want/need team black to protect us from something and or no other way to get things done? What is the risk of not doing these things?

Sean:

What is the risk of not doing what things?

Jon:

Team black writ (at) large

We don't want to risk undermining national security

Sean:

I would say to a certain extent, yes, but not without congressional oversight and a process to justify appropriations. Beyond that, I don't know, I can't see the forest for the trees.

Jon:

Gotcha! That's what members are trying of thread the needle on. Establish some oversight but keep things moving forward.

Can you help me understand why signal isn't secure?

Sean:

Regarding the security of signal.

I don't really know why not. But from what I understand, it has more to do with the devices in which signal is download on not being secure as opposed to the transmission of messages within the application itself.

Any device which can host the signal application can also host a scraping spyware that can monitor the device.

Think of it like a screen recording.

Signal is not getting hacked - the display of the devices is. Further, though, I know the FBI can get access to the transmissions themselves and as of right now, the FBI cannot be trusted on mass.

Jon liked message

Jon:

Got it. Thanks

Is there still conflict between blue and black?

If someone had blackhawks and police helicopters circling low over house what does that mean and who is doing it?

Sean:

Regarding the police/helicopter question. That is someone like me.

The question of "who" is hard to comprehend from the world we are used to. Black team has a nebulous network that extends across all different agencies, including local, law-enforcement, district attorneys, judges, entrepreneurs, etc. It is quite literally a secret society in the most basic definition.

The assets, Helicopter, and vehicles, probably belong to a private contractor who has a legitimate business as a cover.

Legitimacy is the best cover. That is a rule we live by. It takes a lot of work.

Regarding the question, is there still conflict between blue and black? I'll take that opportunity to say that just like Big Team Blue became compromised by Black Team over the last 80 years, those of us who bleed blue on Black Team are now forming a secret blue blooded alliance within black team. We are weaponizing compartmentalization.

Prior to the WB movement catching wind my team and I had devised a plan to expose information, have it confirmed, while maintaining anonymity. This plan was to do so via a manuscript submitted to the Defense office of Prepublication and Security Review in 2019. This book was written as historical fiction by a ghostwriter in 2019 on our behalf. It was produced by my team as a reconnaissance effort directed at the D.O.D.

The first two chapters was approx. 9,000 words of a 130,000-word manuscript submitted to the Defense Office of Prepublication and Security Review on April 09, 2022. In addition to D.O.D.'s review, we were told by that office that the manuscript was sent to outside S.M.E. (Subject Matter Experts) for review as well (this means SAP's).

The reason I am sharing this now is because it corroborates and edifies the account by Michael Herrera.

Our intention is to put the D.O.D. in a pickle by creating dilemmas. We are strategically taking advantage of the fact that they must respond. They don't have a choice – no poker face. Any response will provide us with information/intelligence and inverse intelligence.

Our book contains 4 categories of information. A-D:

- A. Sensitive information known to be considered classified by the D.O.D.
- B. Sensitive information known to exist only within the hearts and minds of those involved within the extra-congressional Deep Black agencies of SAP.
- C. Open-source information (available on the internet) but may be considered classified.
- D. Fictional information pseudo facts and narratives produced by our ghostwriter.

The Pickles -

- 1. Any redaction of information 'A' accredits that information as being legitimate and confirms we are in possession of classified information. We will publish the book with lines blacked out as well as rewrite around that information to lead the reader to make solid guesses about what is behind the redactions.
- 2. Any redaction of information 'B' proves that there are agents within our own government aiding and abetting Black Team's illegal activities.
- 3. Conversely, not redacting 'B' information proves the government is not "read in" and that the Deep Black of SAP is rogue.
- 4. Redacting information 'C' accredits open-source platforms like Wikipedia and proves the government's right hand doesn't know what its left hand is doing this is the double-edged sword of compartmentalization.
- 5. Any redaction of information 'D' meant we went fishing and got somethings right. This is confirmation of educated guesses.
- 6. Finally, keeping in mind we are playing 4-dimensional chess, there is a counter play here. We could see willful/intentional non-redaction of any of the above categories (A-D) in order to indirectly declare sensitive facts as fiction. This would be a counterattack of disinformation officially sealing our content as the fictional writings of a creative author, or what I call "Faction".

Our first 20 pages took the DOPSR 6 months to review and came back with 7 pages of redactions. We were told we must submit the full manuscript and they would no longer review it in chunks. We are working on that as we speak.

Jon:

That's a brilliant approach!

So you eventually will publish or only use to test?

Our best approach on my side is to let the language in the NDAA get to finish and reassesses then. This is a marathon.

If you want some low-hanging-fruit actionable-intelligence on this subject right here (Harassing Helicopters and police) I could put you to work on this right now. Today. Let's go to work. What do you say?

Jon:

Sure what do you have? Unfortunately I have personal experience

Sean:

If you need PPD - private, I have a very small team of Good Guys. The best humans you will ever meet. Worked with me for over 25 years. They are uncompromisable moral treasures. I know that is asking a lot for you trust wise. Trust is earned. But if there is a way to earn your trust, I can send you one of my best guys to try out. We also have a fleet of brand new, fully armored Yukon Denali's. He would provide your 24/7 security and transportation. All private registered assets.

Not meat heads. Actual socially pleasant and professional.

Regarding actionable intelligence. I know the group providing harassment, intimidation, and blackmail in your area.

Jon liked message

Jon:

That's good to know re PPD.

I will need one occasionally for follow on career and know guys that may need one.

Sean:

Are you familiar with the Gilgo Beach case?

Jon:

Negative.

Rex is a patsy/fall guy protecting members of the group.

Jon:

Holy shit.

What do you recommend for me to do reg choppers. I have exact timing and videos for many. Never on radar

Send me what you have regarding you encounters. Can you send a cloud link?

Jon:

Yes I think so. Can we switch to signal or not feasible?

Sean:

There is a Black on Black war taking place. Good guys here trying to expose the bad guys so we all don't go down as casualties- guilt by association. We have infiltrated this group and have been imbedded for a year. The day after we won a major micro battle -- Rex was taken down literal feet away from my guy.

This runs deep and complex. I can send you a full report but will need a couple days. This Black circle is responsible for murder, blackmail and is behind the compromise of a number of government officials.

Jon:

Roger. Let us know who if you can.

So Rex is one of your guys?

Sean:

No. My guys was tracking the FBI agent who there when he was arrested. We never heard of Rex until he was taken down. Come to find out he was a random patron of some of the "sex" parties hosted by the group and is being framed. He never killed anyone. But is being framed. We know who committed his murders. Same group responsible for 19 murders we know of.

Jon:

(link: helicopter videos over house)

This is a couple but there has been more than 10.

Sean:

We can switch to Signal. Give me a couple hours. Going off line for a bit. Talk to you soon. I will do everything in my power to help you. I am here.

Jon:

Thanks brother! Talk later.

What would general cost be for PPD?

700-1000 per day. Vehicle included

That's my raw operating costs.

Jon:

Roger!

That's not bad

My current salary is laughable but I know ballers that may need good folks here and there

Sean:

Would it be OK with you if I shared our discussion today with Grusch?

Jon:

That's ok by me Thanks for asking

Sean:

Rgr

Out of all the places we could start working together, I think we need to start with the Gilgo group. Because if we can't have you guys free of threat and compromise, we won't even get this shit off the ground. We need your sanctity and safety made a priority.

Jon:

Agreed. Not sure if I'm tracking exactly what you're suggesting.

Can we pivot to signal

Sean:

By tomorrow yes. I will text you when I am up and running on it.

Jon liked message

Sean:

What I am saying -

Secrets needs sentinels, just like walls need guardians. This is how black team has preserved its place.

Until you, and others like you, are free of compromise, harassment, and intimidation, we will get nowhere. This is the barrier of entry into everything else.

I'm suggesting, as a proof of concept, that concept being our effectiveness to work together, perhaps we should start by taking out the Gilgo Group, let's call it G2. If we are not successful at that, we are fucked. Excuse my candor.

If we are effective at that, at winning that battle, and we begin to see more black team members come forward, then we might have a chance at winning the war. And maybe everyone will get to see the assets and biological data (the shiny stuff) everyone is so enamored with.

My team has been working to infiltrate these sentinels of ether for a long time and turn the tables. We need help.

Jon:

Roger. Makes perfect sense.

We have a fleet of helicopters too. Come with pilot/body guards. For PPD.

Jon:

No a buddy that advises Congress.

Dude is loaded

Lives on huge farm

Sean:

Got it.

Download this app and watch a tutorial on how to use it on YouTube. Give it to him. You could hold your phone up to the sky. It works like IFF. (identify friend or foe). If it is friendly, Faa compliant, you will get a ton of data appearing on your screen identifying the aircraft. No data means it's a ghost ship.

Jon liked message

Jon:

I was using this

All ghost but one BH

He uses this as well...all ghosts

Sean:

Well that takes us to the next step. I put one of my guys at his farm on standby in a fast helicopter. When they show up again we launch and follow their ass and take them into custody and integrate them.

They will shit their pants.

My guys are always the scariest humans - in every room they walk into. And the strongest because they dont cower to evil.

Jon:

Lets do it!

Sean:

If the guy is flipping the bill.

It's a good ice breaker for our relationship. We can debrief afterwards.

Jon:

I'll ask him. Daily cost?

He is thinking about it. Thinking it will cause a shitstorm after the fact for him and family

Sean:

Will need to discuss some more details before I can put together an accurate quote. Not looking to make a profit just cover the cost. Also, I need to know where we stand on the spectrum of diplomatic immunity versus plausible deniability. Who is going to bail us out if shit goes south?

Legally

Jon:

K crashing

Talk tomorrow.

Sean:

I would tell him it's too late for that. We are all in this position now. He is damned if he does and damned if he doesn't. It's better to be a man who's damned if you do. This is no shit the revolution of our country's lifetime.
